STRUCTURE, GOVERNANCE AND MANAGEMENT

The Charity is a company limited by guarantee and was incorporated on 1 March 2010. The Charity is governed by its Memorandum and Articles of Association. It is registered as a Charity with the Charity Commission. The liability of each member in the event of winding up is limited to £1.

During the year the Trustees make decisions regarding strategic matters. However, the Chief Executive Officer makes decisions regarding the day-to-day running of the Charity.

The Trustees have conducted a review of the major risks to which the Charity is exposed, and systems have been established to mitigate those risks. Internal risks are minimised by the implementation of procedures for authorisation of all transactions and projects and to ensure consistent quality of delivery for all operational aspects of the charitable company. These procedures are periodically reviewed to ensure that they still meet the needs of the Charity.

Trustees are appointed by invitation and welcomed officially at the AGM. Before appointment, all trustees are interviewed and references taken, they will be in good standing with their local church.

OBJECTIVES AND ACTIVITIES

To promote the physical, mental and spiritual wellbeing of the inhabitants of localities across the UK and the world; by, in particular but not exclusively by the provision of pastoral care and the formation of a Street Angels programme for the benefit of the local community without distinction of race, sex, political, religious or other opinion of the members of such a community.

To support, care and treat persons in need who are homeless and suffering from the effects of poverty, sickness, disability, old age, alcoholism, drug addiction, offending behaviour, or any other mental or physical infirmity, as an expression of Christian faith.

PUBLIC BENEFIT

In planning the charities activities for the year, the Trustees reviewed the guidance from the Charity Commission and have had regard to the Charity Commissions guidance on public benefit.

I would like to thank Graham our Finance Officer for his help on the day to day finances of CNI.

We continue to look for new Trustees to reinvigorate our Board and the vision of Christian Nightlife Initiatives, please get in touch if this interests you.

We have been extremely lucky over the past few years at receiving generous support from Christian Charities however this funding has now come to an end and as Trustees we continue to explore new funding opportunities and as you will see from our accounts the income we received is relatively small considering the vast range of work that has been done by Paul and Katie in developing the various strands and resources which CNI makes available to the projects and communities.

Finally I would like to thank my fellow Trustees, Olivia whose support as Vice Chair has been invaluable, Martin whose experience and knowledge has also been invaluable to me and of course as previously mentioned Ian for his help and support whilst on the Board.

I look forward to the next 12 months although with some concern as to how the Coronavirus pandemic will affect everyone but especially our projects and I look forward to working with Paul, Katie, Olivia

ACHIEVEMENTS AND PERFORMANCE

CEO's Report

This has been another busy year in the life and ministry of CNI Network. As the CEO and founder, I am so thankful for those who stand with us in our vision of #MakingCityStreetsLikeNewAgain (taken from Isaiah 58) through local projects, volunteering, supporting financially, prayer and partnership. We are very much a family who work together to bring change to local communities and people.

We have attended a good number of conferences this year including a #FaithAndPoliceTogether day at the Police College in Coventry. This ministry, which is a partnership between CNI Network, Redeeming Our Communities and Christian Police Association, has been helped by the secondment of an Acting Inspector and has resulted in a fantastic toolkit which is proving to be a great resource to both police and faith communities to do more together to be strategic in meeting policing priorities in communities. Jean and I were also at the Christian Police Association Conference in Harrogate and contributed the prayer for the Annual Report.

Jesus Loves Yorkshire was proclaimed on banners on church buildings around the Tour de Yorkshire event in May. The banners, along the same designs as the Jesus Loves Festivals and Jesus Loves Clubbers images, were featured on the international TV coverage of the race letting the world know that Jesus does indeed love Yorkshire!

The number of talks and conference events I was given the opportunity to speak at has increased. This helps promote the work CNI Network and our local projects, as well as bringing in finances. We have also produced a video of the talk which one of the speaker finder websites is promoting to those who are isolating due to the coronavirus which was just beginning as the year ended and sadly led to the cancelling of 10 talks in the new financial year.

Jean, Katie (our Yorkshire Regional Coordinator) and I have had the opportunity to visit several of our local projects to help celebrate anniversary events, AGM's or to join the teams on patrol. It is always good to see the vision as a reality and meet those who volunteer and those who have received help from our teams.

Festival Angels work increased dramatically this year as we were present at 16 music festivals across the UK and supported others including one in Spain. It is great to receive phone calls from festival organisers who have heard of Festival Angels and want a team at their music festival or event. We have an amazing group of regular volunteers now and so we can confidently say yes to new festival opportunities. Sadly the weather (high winds) meant Boardmasters was cancelled which was a shame for our team and the festival-goers but the others carried on including a gloriously sunny with no rain at both Leeds Festival and We Are Church at Creamfields (truly a miracle!) - our teams rose to the challenge of making sure people were hydrated as the infrastructure struggled to cope with demand on the temporary water supplies. Leeds Festival Angels was featured on BBC Look North and the BBC social media. We also supported a Northern Ireland Festival Angels team who worked at 2 festivals in Belfast. Sadly, much of our festival work will be on hold for 2020 as coronavirus sees gatherings cancelled (this will mean a shortfall in our planned income) but it is hoped the later summer ones will continue including Festival Angels in Upton-on-Severn led by the Baptist Church.

I had the opportunity to speak at 5 church communities in America in June as CNI Network continues to look at openings in the USA. We caught up with the Wilmington North Carolina Street Angels team and encouraged them in the work they are doing.

We have connected with new groups such as the YWAM Summer Nightlife Outreach, working in holiday resorts across Europe and groups looking at starting new Street Angels projects including a Bus Ministry, Destination 211, in Dewsbury. I have continued in my role as a Queens Award for Voluntary Services assessor as part of CNI Network's investment into the wider volunteer family.

Congratulations to Pip Moscrop coordinator of Macclesfield Street Angels who received a British Empire Medal in the 2019 Queen's Birthday Honours. Pip has an amazing ministry and is at the heart of a lot of Christian based activity in and around Macclesfield so this honour is truly deserved.

CNI Network has continued in its social media and website, recognising, this is a keyway of keeping in touch and celebrating good news stories. Our media coverage has continued including in the Sunday Mirror, various BBC local radio stations, UK Charity Week, local BBC TV, Premier Radio, TransWorld Radio, UCB and the Praxis Hopeful Activist podcast. In 2020 we started a new feature in partnership with Inspire Magazine, Community Heroes.

CNI Network produced a 30 days Prayer and Action Guide with several local projects contributing. This has helped local projects with marketing within local church communities and received some moving feedback from people reading the Guide.

When you look at our activity and then our expenditure of £43,000, I think we manage to achieve a lot on a very reasonable budget! As I write we are 2 weeks into the coronavirus lockdown which could well change the dynamics of the night-time economy once it is all over. Our teams and CNI Network are ready for the challenge in the new reality we will find ourselves in - offering support and prayer to pub and club staff and looking at how we operate within this new culture. 2020 is set to be an interesting year and yet we want to encourage our local projects to be pioneering and innovative in the work we do.

FINANCIAL REVIEW

The operating deficit for the year was £14,642 (2019 -£1,954 deficit) which has been deducted from reserves. Reserves at the end of the year were £13,782 (2019 - £28,424) which are used to finance additional projects, trading in the ensuing year and as backup reserve.

The charity has unpaid volunteers to help run its various activities.

Reserves policy

CNI Network will not allow general income (bank and cash) to fall below £500 - this does not include finances that are set aside for specific purposes. The Agreement for a Local Branch is found at www.cninetwork.org/localbranch (this covers financial guidelines).

1. GENERAL INFORMATION

The charity is a public benefit entity and a private company limited by guarantee, registered in England and Wales and a registered charity in England and Wales. The address of the registered office is The King's Centre, Park Road, Halifax, HX1 1HU.

2. STATEMENT OF COMPLIANCE

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland', the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)) and the Companies Act 2006.

3. ACCOUNTING POLICIES

Basis of preparation

The financial statements have been prepared on the historical cost basis.

The financial statements are prepared in sterling, which is the functional currency of the entity.

Going concern

There are no material uncertainties about the charity's ability to continue.

Judgements and key sources of estimation uncertainty

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the amounts reported. These estimates and judgements are continually reviewed and are based on experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

There are not considered to be any judgements or accounting estimates or assumptions that have a significant impact on the financial statements

Fund accounting

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes.

Designated funds are unrestricted funds earmarked by the trustees for particular future project or commitment.

3. ACCOUNTING POLICIES *(continued)*

Incoming resources

All income is included in the statement of financial activities when entitlement has passed to the charity, it is probable that the economic benefits associated with the transaction will flow to the charity and the amount can be reliably measured. The following specific policies are applied to particular categories of income:

- income from donations or grants is recognised when there is evidence of entitlement to the gift, receipt is probable and its amount can be measured reliably.
- legacy income is recognised when receipt is probable and entitlement is established.

Resources expended

Expenditure is recognised on an accruals basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is classified under headings of the statement of financial activities to which it relates:

- expenditure on raising funds includes the costs of all fundraising activities and events.
- expenditure on charitable activities includes all costs incurred by a charity in undertaking activities that further its charitable aims for the benefit of its beneficiaries, including those support costs and costs relating to the governance of the charity apportioned to charitable activities.

All costs are allocated to expenditure categories reflecting the use of the resource. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs are apportioned between the activities they contribute to on a reasonable, justifiable and consistent basis.

Financial instruments

The company only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

Defined contribution plans

Contributions to defined contribution plans are recognised as an expense in the period in which the related service is provided. Prepaid contributions are recognised as an asset to the extent that the repayment will lead to a reduction in future payments or a cash refund.
